SAMPLE PROCUREMENT



As Secretariat, one of our most important tasks is to procure sample sets on behalf of Collaboration Members. Recent growth of Oneworld Accuracy programs and especially of Collaboration Members has significantly increased the complexity of this task.

Our goal is to simplify and streamline sample procurement to make it more transparent and responsive to the needs of Collaboration Members. To this end, we've created this Sample Set Order Calendar which has a set of clearly defined deadlines, by which you have to order sample sets for specified programs | test events. Make sure you don't miss these deadlines.

This will enable all Collaboration Members to know precisely when they have to place orders for sample sets to meet the needs of their current and prospective participants. The functionality of the Sample Set Order Calendar will ultimately be added to OASYS.

SAMPLE PROCUREMENT FAQs



Q. How are Oneworld Accuracy programs organized?

A. Here's how:

- All programs are provided on a calendar year basis.
- Participants can start programs at any test event, provided sample sets are available.
- All participants finish programs at the last event in the year.
- We help you to renew your participants' programs from year to year.
- Once your participants are enrolled in OASYS, we automatically order sample sets for all programs for all remaining test events in the year.
- This means you only need to order sample sets for new programs for current participants already enrolled in OASYS and for prospective participants not yet enrolled in OASYS.

Q. Is sample procurement a profit centre for the Secretariat?

A. No, we manage sample procurement on a cost recovery basis on behalf of all Collaboration Members. By acting as a group purchaser, we secure better sample set pricing and pass those savings on to you.

Q. Do you order extra sample sets?

A. Yes. We order extras to accommodate replacement sample sets. Extras vary by program, but we typically order 5% extra.

Q. What problems are you seeking to solve with the Sample Set Order Calendar?

A. We're trying to solve two problems – not enough samples and too many samples. The challenge is to ensure that we order enough samples on your behalf for your current and prospective participants while minimizing our losses for unused samples. Since we manage sample procurement on a cost recovery basis, these losses compromise our group purchase business model.

Q. How does the Sample Set Order Calendar help solve these problems?

A. It makes explicit the order deadlines so you can make an informed business decision about how many sample sets to order.

Q. What sample sets do I need to order?

A. You only need to order sample sets for new programs for current participants already enrolled in OASYS and for prospective participants not yet enrolled in OASYS.

SAMPLE PROCUREMENT FAQs

Q. When do I need to enroll prospective participants in OASYS?

A. You need to enroll prospective participants in OASYS not later than 60 days before the test event opens so we can link their identity (OASYS ID, address, shipping contact, etc.) to their sample sets. If you fail to enroll by this date or at all, we will ship you the sample sets and invoice you in the normal course.

Q. Do I need to order sample sets for current programs for current participants already enrolled in OASYS?

A. No. We automatically order sample sets for these programs for the remaining test events in the year on your behalf.

Q. How do I place my sample set orders?

A. Please contact support@1WA.org or your Account Manager by the deadlines specified and email the order. We'll then place your order with the sample providers.

Q. Is my order a binding legal commitment?

A. Yes. You know your market best and so assume all business risk for placing your order.

Q. What happens when I place my sample set order by the deadline?

A. We will confirm your order by return email. We will then assemble your order and those from all Collaboration Members and place binding purchase and production commitments on your behalf with our sample providers. We will invoice you in the normal course.

Q. What happens if I miss the deadline?

A. We won't be able to fulfill your order for the test event start date you've requested. Those participants will have to start at the next available test event.

Q. Can I cancel or revise my order before the deadline?

A. Yes. You can revise or cancel your order in writing before the deadline as we've not yet made legal, binding purchase commitments on your behalf to sample providers.

Q. Can I cancel or revise my order after the deadline?

A. No. You cannot revise or cancel your order after the deadline. After the deadline your order is a legal, binding purchase commitment, upon which we make legal, binding purchase commitments on your behalf to sample providers.

Q. Can you help me if I ordered too many sample sets?

A. Yes. We will see if other Collaboration Members can use your extra sample sets. However, if we can't find a home for your sample sets, then you will be responsible for their cost.

SAMPLE PROCUREMENT FAQs

Q. Can I cancel programs for participants?

A. Yes. You can cancel programs for participants at any time, but you will be responsible for sample sets for the programs | test events we've ordered from sample providers on your behalf.

Q. Why do I have to order sample sets for all test events in the year for some programs?

A. Some sample providers do annual production runs. Accordingly, they require that we provide them a single annual purchase order. We recognize that this means you have to make a projection of orders, which is inherently difficult and has associated business risk (e.g. not enough sample sets or too many). Having said that, Collaboration Members are in the best position to assess and assume that risk.

Q. What improvements do you seek with sample providers on our behalf?

A. We're constantly working with sample providers to (a) improve their pricing, (b) reduce their production lead times and (c) produce samples for each test event rather than annually.

Instructions

1. Review the 2020 Sample Set Order Calendar, which lists all programs, and the 2020 Sample Set Order Calendar for Yearly Programs, which lists programs whose sample sets are produced on a yearly basis. Please contact us by the deadlines indicated.
2. Most sample providers produce their sample sets on a test event basis. In the example below, BLPA435 is a Parasitology EQA program for which you have to order sample sets for the 1st test event for the year by the deadline indicated.
3. Some sample providers produce their sample sets on a yearly basis. Accordingly, you will need to place your sample set orders for these programs for all test events in the year. In the example below, HIVL435 is a Clinical Nucleic Acid Testing EQA program for which you have to order sample sets for all test events for the year by the deadline indicated.

1. By placing your order, you agree to these standard terms.
2. Unless specified otherwise, payment is due net 30 days after receipt of our invoice. Overdue accounts may bear interest at the rate specified on our invoice. We reserve the right to require payment prior to shipment and to withhold shipments and/or performance information for overdue accounts.
3. YOU MAY REVISE OR CANCEL YOUR ORDER IN WRITING BEFORE THE SPECIFIED DEADLINE. THEREAFTER, YOUR ORDER BECOMES A LEGAL, BINDING PURCHASE COMMITMENT, UPON WHICH WE MAKE LEGAL, BINDING PURCHASE AND PRODUCTION COMMITMENTS ON YOUR BEHALF TO SAMPLE PROVIDERS AND, ACCORDINGLY, CANNOT BE CANCELLED OR REVISED. YOU ASSUME ALL BUSINESS RISK FOR PLACING YOUR ORDER. YOU MAY CANCEL PROGRAMS FOR PARTICIPANTS IN WRITING AT ANY TIME, BUT YOU WILL BE RESPONSIBLE FOR SAMPLE SETS FOR THE PROGRAMS | TEST EVENTS ORDERED FROM SAMPLE PROVIDERS ON YOUR BEHALF.
4. Samples may require import permits. You are responsible to obtain all required import permits to ensure timely customs clearance and delivery. Contact your local authorities to determine import permit requirements.
5. You may request replacement samples by using our standard administration form. Missing samples or samples compromised during shipment will be replaced at our cost. Samples compromised due to missing or incomplete import permits or customs delays and samples compromised after your receipt will be replaced at your cost based on the prevailing price list pro-rated by test events plus any applicable shipping charge.
6. Samples may contain pathogenic materials. You assume all risk and responsibility for the proper receipt, handling, storage, testing and disposal of samples and all associated reagents and consumables used in the testing process.
7. Samples, their progeny, unmodified derivatives or modifications thereof may not be transferred or incorporated into a product intended for sale.
8. You may exclude participant evaluation for a single test event by providing at least 60 days notice before the test event open date by using our standard administration form. Exclusions do not qualify for a credit note (or refund).
9. We reserve the right to not offer programs with less than 10 participants by providing you notice and a full refund.
10. Our sole and exclusive liability arising from your sample set order shall be limited to a refund of your purchase price.

PARTICIPANT STANDARD TERMS



These standard terms apply for all participants in Oneworld Accuracy programs provided by all Members of the Oneworld Accuracy Collaboration. Collaboration Members may include additional terms for their participants provided they do not compromise these standard terms.

1. By placing your order or participating in programs, you agree to these standard terms.
2. Unless specified otherwise, payment is due net 30 days after receipt of our invoice. Overdue accounts may bear interest at the rate specified on our invoice. We reserve the right to require payment prior to shipment and to withhold shipments and/or performance information for overdue accounts.
3. You may cancel programs for which we have not yet shipped samples by providing at least 60 days notice before the test event open date by using our standard administration form. We will provide a credit note (or refund) of 90% of your purchase price pro-rated by remaining test events. Any annual registration fees are non refundable.
4. Samples may require import permits. You are responsible to obtain all required import permits to ensure timely customs clearance and delivery. Contact your local authorities to determine import permit requirements.
5. You may request replacement samples by using our standard administration form. Missing samples or samples compromised during shipment will be replaced at our cost. Samples compromised due to missing or incomplete import permits or customs delays and samples compromised after your receipt will be replaced at your cost based on the prevailing program cost pro-rated by test events plus any applicable shipping charge.
6. Samples may contain pathogenic materials. You assume all risk and responsibility for the proper receipt, handling, storage, testing and disposal of samples and all associated reagents and consumables used in the testing process.
7. Samples, their progeny, unmodified derivatives or modifications thereof may not be transferred or incorporated into a product intended for sale.
8. You may exclude evaluation for a single test event by providing at least 60 days notice before the test event open date by using our standard administration form. Exclusions do not qualify for a credit note (or refund).
9. We reserve the right to not offer programs with less than 10 participants by providing you notice and a full refund.
10. Our sole and exclusive liability arising from your sample set order shall be limited to a refund of your purchase price.
